(Pen. Code, § 1203; People v. Walker, supra, 104 Cal.App.2d 128, 132; People v. Dilworth, supra, 169 Cal.App.2d 446, 448-449.) The effect of an order changing custody is not a matter of custody but a change in procedure. It does not affect a change in custody. There is no order which can serve as a transfer of custody. (In re Aragon, supra, 176 Cal.App.2d 926, 928; People v. Walker, supra, 104 Cal.App.2d 128, 133.) It is clear that the distinction between "custody" and "transfer of custody" is well established. Custody refers to an area in which the prisoner may be confined; this is a technical legal term referring to the point at which a court orders a prisoner to serve a sentence, and he must remain there until discharged by the court. In a transfer of custody proceeding a prisoner is not returned to a term which the court has imposed. (In re Aragon, supra, 176 Cal.App.2d 926, 928; People v. Walker, supra, 104 Cal.App.2d 128, 133.) [1b] Under the cited cases appellant was not "placed in custody." (Pen. Code, 3049; People v. Walker, supra, 104 Cal.App.2d 128, 132.) The order changing custody and transferring custody to the department of parole and probation was not a "judgment of commitment" under section 3045. (In re Aragon, supra, 176 Cal.App.2d 926, 928.)
